RELEASE, WAIVER, INDEMNIFICATION, HOLD HARMLESS, AND ASSUMPTION OF THE RISK AGREEMENT

WHEREAS, in return for instruction in firearms, use of premises, and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Undersigned agrees to the following:

The undersigned agrees to indemnify, hold harmless, and defend Maui Center Target, Inc & Handley's Gun Supply and any of the property owners and heirs, the assigned firearms instructors, staff, directors, officers, employees or agents(hereinafter FST) from any and all fault, liabilities, cost, expenses, claims, demands or lawsuits, arising out of, related to or connected with: the discharge of firearms, the course of instruction; the Undersigned's participation in the course of instruction; the range, buildings, land and premises used for the course of instruction(hereinafter the Premises); the Undersigned presence on or the use of said premises; and any and all acts of omissions of the Undersigned. And should any such claim, demand or lawsuit arise or be asserted in any way whatsoever related thereto, whether arising under the laws of the United States or of any State, or under any theory of law or equity, the Undersigned will indemnify, hold harmless and defend FST from any and all costs, expenses, or liability including, but not limited to, the cost of any settlement or judgment made or rendered against Maui Center Target, Inc whether individually or jointly with the Undersigned, together with all costs of court and other costs or expenses incurred in connection with any such claim, demand, lawsuit, including attorney's fees.
